EXTENSION OF "SEWAGE DISPOSAL CONTRACT"

WHEREAS, the undersigned municipality entered into the attached Sewer Disposal Contract sometime during or close to the date of May, 1962, with Belmont County Sewer Authority No. 1, and

WHEREAS, Belmont County Sewer Authority No. 1 has now changed its name to Eastern Ohio Regional Waste Water Authority (hereinafter referred to as The Authority), and

WHEREAS, the undersigned municipality and The Authority have been acting under said May, 1962 contractual arrangements, and

WHEREAS, the undersigned municipality has not been able to ascertain the location of the original May, 1962 contract, which was for a term of at least fifty (50) years; and

WHEREAS, the undersigned municipality and the authority wish said contractual arrangements to continue as has been done for the last several decades.

NOW THEREFORE, the parties agree as follows:

The undersigned municipality and The Authority hereby agree that the attached agreement shall continue in full force and effect for a period of twenty-five (25) years from and after the Effective date hereof or as for such longer time as may be necessary to continue it in effect for so long as any revenue bonds of The Authority issued during the aforesaid period shall remain outstanding and unpaid.

AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO AN EXTENSION OF "SEWAGE DISPOSAL CONTRACT" WITH THE EASTERN OHIO REGIONAL WASTE WATER AUTHORITY.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MARTINS FERRY, COUNTY OF BELMONT, STATE OF OHIO:

SECTION 1: That the Mayor, on behalf of the City of Martins Ferry, be and is hereby authorized to enter into an Extension of "Sewage Disposal Contract" with the Eastern Ohio Regional Waste Water Authority, a copy of which shall be maintained in the Mayor's Office in a file bearing the same number as this Ordinance.

SECTION 2: That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3: That this Ordinance shall take effect and be in force from and after the earliest period allowed by law.
